Title of Programme/Project

1. Education to Empowerment-Pillars of Learning (save the Children)

Intervention area of this project is 75 Selected Schools and 150 Selected AWCs in Manpur Block of Gaya District in Bihar.

School Intervention:

In this year PGVS was worked with 9055 students of 75 Middle Schools and Primary schools and 150 ICDS Centre in Manpur Block intervention area in till September 2020 ;-

We worked with 150 ICDS Centre 75 schools in Manpur Block Blocks of Gaya district in Bihar from April 2020 to September 2020, we have formed Bal sansad in every school, Bal sansad is strengthened with all aspects like studies, cleanliness, school atmosphere and beautification, uses of suggestion boxes, actively participation with SMC/VSS for discussion, Bal sansad is working for all the students where in this year 9055 students benefitted. Strengthen in child rights, RTE, Child marriage(One child marriage of Pachmahala CRC is stopped by members of Bal sansad during this reporting period) , child labor etc..

**The focus of project to improve health and nutrition of children (0 to 5 years)
pregnant woman & lactating mother**

PGVS has done work with 10 modal AWC and other 30 AWC. For their improvement with support of ICDS department. Total number of 10 modal awc children 2027 (0 to 59 months) including 1048 girl , in which

founder 187 SAM boy and 244 SAM girls .PGVS counselled their parents to put their children to NRC (nutrition rehabilitation centre) And after counselling 9 children with 7 girls had admitted in NRC and get treatment .

Total 125 MAM children has been treated including 64 girls and 400 children has been enrolled And total 1552 children of AWC has benefited

PGVS has given Carpets , weight machine ,baby weight machine , height machine drinking water filter jar and wall painting in AWC. PGVS also provide IES learning materials in 10 modal Anganwadi.

Supportive Supervisory Feeding Program for SAM and MAM children

10 NCCS Session has been organized in ten model AWC. This NCCS session was comprised of three days. Day one dedicated to screening of children and day two for counseling whereas Day 3 is dedicated for recipe demonstration.

Total 496 Children were screened then boys-258 and girls-238. 125 MAM children identified. 125 mothers participated in counseling session and recipe demonstration. There are many children in improvement.

Rauniya-1st

VHSND

VHSND conducted in 3 AWC centers .In which Iron tablets given to Adolescent girls and pregnant women participat-9. Iron Syrup given to children. Apart from this immunization given to children total participat 12 children as per schedule (Penta, Polio, Rota-ii) .Immunization also given to pregnant lady (TT,Buster-I DT Buster-2nd and 3rd).

Nutrition commpiyan Rath organized 32 AWC and participat 800 people Than boys286 girls 108 woman-238 mam168 participat. And by this campian people make aware for nutrition.there are many activity in this campion like Hand wash , Nuturation rally , salogan etc.

Urban resilience project

Increased preparedness and resilience in urban communities and schools in India

Goal of the intervention:

Child friendly, gender sensitive and inclusive risk reduction and resilience¹ is adopted and mainstreamed in urban communities, schools and city governance in India, by urban government's bodies in the cities of Patna.

PGVS started project in mid-September but due to amendment of FCRA ACT Project end 30th September 2020 .

Rossini Project

Create a child centred and child friendly environment where voices of children are get heard and their view can be considered. This will create child leadership in governance processes from the ground level which can be replicated and adopted in the decision making process. When children will be the key member of decision making process, they believe in their own ability to make a difference, may be more vocal about abuse or exploitation and gain the political and social awareness of their rights and responsibilities. Children participation leads to fulfilment of other rights. When children involve as a part of decision making, provides a means of protecting them from harm and preventing them being invisible when discussing plans, framing the policies and designing the services or making decision that affect their lives. Child participation will go towards the change of society.

Reach (including profile of population and number):

More than 250 children would be directly impacted and indirectly it would affect the lives of around 500 or more people.

Patna is the capital of Bihar and the largest urban area. The town is located in Patna district that comprises of six sub divisions. The Patna Municipal Corporation area covers 99.45 sq km and is divided into 72 wards. PGVS support one volunteer to work with their respective adolescent girl to make in slums for their upliftment of health education and children rights. PGVS Form 20 adolescent groups in kamlanehru slum and make network with other slum adolescent group

Organize training of group leaders regarding children rights as UNO total 60 leaders got group leader training at PGVS campus .

They meet ward counsellor and local MLA and submitted chatter of demand related basic facilities of children in slums

2. People Led Action for Suitable WASH Services (JSCF)

Goal of Programme

The main aim of the program is “to reduce the vulnerability of the community against ailing effect of unsafe drinking water, poor sanitation, unhygienic conditions and to improve the standards of living” through fulfillment of the main objective “to Enhance the Health and quality of life of the poor and vulnerable people by improving access to water

Objectives of Project

Communities get improved and sustainable access to WASH through capacity building of community institutions and Rural local bodies for leveraging Government resources of NRDWP, SBM (NBA) in Gaya district of Bihar through District wide approach with an aim to achieve District WASH Services Improvement through targeted service delivery for unreached households and communities.

COVID 19 Emergency Responses

- **Establishing hand washing station in local markets**

Rural market/ haat in villages in Gaya started to observe retail vendors with staggering sale of local essential goods and household items like vegetable, utensils, etc. There is an immediate need to strengthen the health and hygiene system of targeted areas with special focus on preventive healthcare and behaviour under COVID 19 situation. Through structured hardware interventions such as installation of mobile hand washing stations and awareness especially focused towards the marginalised and vulnerable section of community morbidity and mortality rate can be minimised manifolds. Three units of mobile hand washing stations were installed in Gaya and below mentioned locations were selected for intervention

Budhgere Bazar is organised on every Thursday.

Around 1000 people visit to this haat every Thursday to purchase their daily need products. It is one of its largest organised haat in this area which sells vegetables, cloths, ration as well as livestock's such as cow, buffaloes, goat, etc. People from nearby village such as Tetariya, Harli, Mayapur, Lakhanpur and Guara depend on this market. As per current situation government has occupied all the land nearby road side and the existing structure is being demolished and infrastructural changes are taking place. Hence we decide to install one unit of hand washing station at this location. It is just beside a school hence not only the visitors to the haat but also the students will get befitted from this unit of mobile hand washing unit. It is

connected with a running water supply unit available in the area. We interacted with the haat management committee and the local residents and vendors at the location before installation of the unit and responsibility regarding its operation and maintenance were assured.

- **Provisioning/ retrofitting of WASH facilities in health facilities including provisioning for hand washing station**

Under the current situation of COVID 19 people face an increased risk of infection by seeking care in health facilities. Even the workers in in basic necessities including water, hygiene and sanitation. Even the workers in in adequate quantity of safe water and hygiene services. In present context effective hand hygiene in health care facilities has been the core stone of infection prevention and control. With principal target to improve hand hygiene we targeted three health facilities in Gaya district and equipped them with mobile hand washing station.

The health centre management committee ensured to take proper maintenance of the unit.

Currently the PHC serves with running water facility, availability of safely managed toilet, drinking water facility and hand washing station.

PHC fatehpur is situated 30 kms from Gaya district headquarters. There is one PHC and four additional PHCs in Fathepur block serving health services to 2,53,693 populations at block level. One unit of mobile hand washing unit is installed at PHC which is placed at the entrance/ exit gate of building. It is connected to the running pipe water supply system and adequate quantity of soap and water will be available for the visitors. The health Hand pump centre management committee ensured to take proper maintenance of the unit. Currently the PHC serves with running water facility, availability of safely managed toilet, drinking water facility and hand washing



station.

One unit of defunct hand pump was also retrofitted in the premise of PHC. Total depth of this hand pump was estimated at 35 feet whereas the water table is observed at 20 feet during monsoon.

5. Covid Response supported by Phia/ UNICEF

Objectives of the Project

1. The primary objective of the intervention is to create awareness among the rural communities on COVID19 causes, symptoms, WASH related preventive measures, busting myths and misconception around COVID 19 with promotion of Safe practices, correct information around testing and treatment of Symptomatic and asymptomatic cases by the government.
2. To create awareness among communities to avail a basket of social and child protection schemes and relief measures introduced by the central government along with referrals and linkages of most vulnerable and migrant families with associated service provider/institution.
3. Building the capacities of service providers in responding to grievances of vulnerable individuals and families through referrals, linkages and flagging of mapped issues to authorities and institutions.

PGVS work with internet saathi in Gaya and Banka for covid response awareness to community for safety from covid 19.

We worked with 100 internet saathi in both district total 6 block .The three month project start from July and end in September During this period all 100 Internet saathi contact by phone to community pri member and sifferent stake holders to support them for access basic facilities from govt schemes and make safe their life from covid 19 pandemic. Each Inter net saathi have achieve their target 700 people

9. Musahar woman & Girl empowerment

Background of the project:-

Association with SLCW:-

PGVS/EP is associated with SLCW since 2006 for development of Most deprived musahar community specially girls and woman for their empowerment with the help of better education and economic conditions. The musahar community is living in a socially backward state deprived of their basic rights and social statues.

1. Staff orientation meeting :-

PGVS conducted staff orientation meeting for orientation of project objective for the year of 2020. During the orientation sharing the achievements and review the challenges.

We are working in 42 Musahar helmets' in four blocks with four field staff under one coordinator. Team has suggested that we should intervene in 2020 in following area:-

- Proper orientation and awareness of Musahar led ward about covid-19 prevention and ensure food security.
- Proper care of targeted community safety & security in covid- 19 lockdown period.
- Provide essential support relief and other need to community
- Block level meeting and planning with PRI and Block administration for Chief minister 7 nishchay program.
- Strong intervention to enrollment of children in school after opening.
- Orientation of TEACHER, SMC and parents for send children in school
- 10 selected Musahar hamlets for health checkup camp regarding tuberculosis, MHM, and others.
- Focus on social security schemes
- Constitute new village level committee to access benefit of social security schemes
- Insure homestead land to identified homeless people
- Follow up of woman saving group
- Ensure Her ghar nal ka jal to musahar helmets'

2. Monthly staff orientation meetings of staff:-

PGVS proper conducted monthly staff orientation meeting and review of program & activities. But from April to May 2020 fully effected due to complete lockdown in covid-19. The staff were directed to work from home and nearest village. In the year 2020. Total 16 meeting of staff conducted

In February to till March 15th, 2020, PGVS organized orientation meeting with teachers and parents for children to go the meeting some shared their view carelessness of regarding methods .They teachers to take children during Normally the some innovative mobilizing of school. During parents have about teacher teaching request to proper care of the class period. children want tool for learning.



Teachers express their views about facilities and low infrastructure in campus. Also the shortage of teacher in schools.

But due to covid-19 Govt. has announced lockdown from 25th March 2020 there were all activities has post ponded related schools During the campaign 281 children including 165 girls listed for primary school.

We also discussed about the challenge of musahar helmets issues homelessness and wash concern. In Danapur the usari panchayat has got new panchayat sarkar Bhawan ,where all development activities will conduct from here The Block pramukh and mukhiya ask to PRI member and PGVS for help to reach all social security schemes to poor.He also tell to

ward members to focus MPWS in dalit hemlets during this financial year. Some ward member ask to mukhiya about the PDS Ration is not distributed properly to the BPL family.

During the consultation following issues came out by participant(community and PRI members):-

- Gap of linkages with Hospital and PDS dealer and also job distribution during covid-19
- PM aawas yojna not properly reach to beneficiaries
- PDS system not functioning properly
- Mushar has no cash to construct toilet so they demand advance
- MNREGA Job Work not available for landless labour
- ANM not come properly in AWC.

PGVS has request to all PRI members and BDO for help the poor through implementation of Govt. schemes.

5.Musahar specific ward development plan

IN dalit ward workshop and orientation Make agenda for holistic development of ward through Govt schemes ten hemlets(Gidha purab, sakkadih, Bhadwar, chandi, shivchak, usari, shiwala, vasudeva puri, Govai).

During the planning Ward member and community both participated in planning process and taken resolution in ward sabha for development .

In 2 villages Mukhiya also present and he support to community for make plans . The musahar ward member happy due to Govt of Bihar has given power to Ward member to make plan ward level and direct implement. On 15th august 2020 all 10 ward development plan has adopted by panchayat for their demand with follow corona guideline .

During the year regular follow up and advocacy with govt. by PGVS and community Following achievements in dalit wards following achievements are below:-

Construction

- During this period we faced lockdown and not achieve proper access schemes MPWS .In 2020 we support ward member to construct MPWS (Mini pipe water supply system) in five hemlets and repair of mpws in 4 hemlets
- Naali & Gali (Drain and PCC) road in ward constructed in 10 wards of dalit hemlets. Ward members were take initiative to monitoring and implementation of schemes under 7th nishchay. Under the gali naali schemes community get link road from tola to main road.

6. MHM orientation camp :-

PGVS organized menstrual Hygiene Management camp in 12 musahar ward with adolescent girl to promote menstrual hygiene and health care with disposal of waste total 260 girl has been participated in all 12 training in different places .During the training we followed corona guide line with distribution of mask and use sanitizer. In five places The ANM , ASHA and ICDS workers also play the role as trainer ANM had distributed iron tablets during the training . and orient them



about local nutrition food for iron .

7. Social security schemes :-

PGVS has mobilized community to proper access food grain from PDS center as covid-19 schemes mask and other relief materials. PGVS has make list of 356 family who has no ration card and submitted to Jivika samuh for verification,

8. Relief work during lockdown period :-

In covid -19 PGVS done relief work with pro poor and needy persons in project area like distribution of mask, distribution of soap, distribution of food grain(Rice pulse grain salt machis gud, musted oil from other donor support) PGVS also conducted plantation in 5 villages

Following achievement during covid-19 in relief work

1. Food grain distribution in lockdown period - 695 family in 10 villages
2. Mask distribution- 1200 persons including 785 female
3. Soap distribution for hand washing -2586 people
4. Plantation – 650 plant of fruits
